Public Law

Nicola represents Local Authorities, Parents and children through the Children's Guardian and Interveners. Nicola Receives regular instructions on cases involving some of the most serious injuries to children such as fractured bones, brain injuries, sexual abuse, Factitious illness, neglect and emotional harm.
