- Article 2 inquest into the death of a voluntary psychiatric patient who hanged herself on the psychiatric unit
- Inquest into the death of a patient who died following neurosurgery
- Inquest into the death of a patient who died following an overdose of chemotherapy
- Representing a care home at an inquest into the death of a resident
- Inquest into the death of a patient who died following a head injury that went undiagnosed in A and E
- Jury inquest concerning a patient who was PEG fed who aspirated after the feed was provided inappropriately
- Representing the family of a baby who died following injuries caused during his delivery by forceps

Prison related inquests:

- Regularly instructed on behalf of prison and probation authorities arising out of deaths in custody, including:
 - Self-inflicted deaths
 - Accidental deaths
 - Healthcare related deaths
 - Deaths arising out of the illicit use of substances
- Represented the family of a prisoner who hanged himself in his prison cell
