Notable Cases

- R v TB & ors (2024)
Lachlan prosecuted this multi-handed case involving the importation of multiple kilos of drugs from Spain.
- R v FC (2024)
Lachlan represented FC, accused of assault by penetration of a child under the age of 13. The complainant is FC's daughter.
- R v MA (2024)
Lachlan defends MA, accused of possessing a firearm with intent to endanger life following a non-fatal shooting at a public house in Birmingham.
- R v MQ (2023)
Lachlan secured the acquittal of MQ for producing a controlled drug utilising a s.45 Modern Slavery defence, despite a negative NRM finding.
- R v CD (2023)
Lachlan defended CD at trial, who was charged with rape.
- R v YZ (2022)
Lachlan defended YZ, in a multi-handed case, who was facing a number of counts of robbery whilst possessing an imitation firearm.
- Operation Hailwood (2022)
Lachlan defended in this complex, high-value large-scale fraud, involving nineteen Defendants, which the Prosecution alleged lasted for over a decade.
- R v TS (2022)
Lachlan defended in this trial concerning a large number historic sexual assaults of a child under thirteen, by their sports coach.
- Operation Fort (2022)
Lachlan appeared as led junior in a six-week modern slavery and human trafficking trial, with his client first on the indictment. This trial was one of a number of trials subsequent to the largest investigation of human trafficking in the jurisdiction to date.
