She was instructed in *ALO & Ors v Secretary of State for the Home Department*, a landmark judicial review concerning the Afghan Relocation and Assistance Policy (ARAP), which clarified the limits of executive discretion in national security decisions.

She is frequently instructed in judicial review proceedings involving fresh claims, certification under paragraph 353 of the Immigration Rules, and unlawful detention. Her work often involves complex procedural and jurisdictional issues, and she is experienced in drafting grounds for permission and advising on strategic litigation.

Rehana also undertakes work in education law, with a focus on public law issues arising from exclusions and SEND provision. Her experience includes representing clients before the SEND Tribunal and advising on the statutory duties owed to children and young people.
