### Personal Injury

#### Road traffic Claims

- Amputation claim when motorcyclist's leg badly injured when they sought to overtake a car which proved to be turning right into a drive
- Pedestrian crossing road when under the influence of alcohol suffered severe spinal injury when hit by a speeding car
- Severe internal injuries suffered when the Claimant was involved in a serious collision when not wearing a seat belt.

#### Employers Liability Claims
